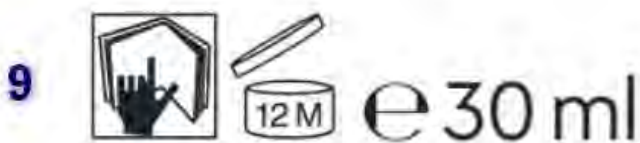


Mandatory information on the label of cosmetic product for realization on the European market

1 REGENERATING GEL

- 2** Wijze van toediening: wanneer het cutaan wordt aangebracht, verbetert het de oppervlakte van de huid en helpt het de huidtextuur te herstellen. Opslag omstandigheden: bewaren bij een temperatuur van 0 tot 25 graden Celsius. Voorzichtigheidsmaatregelen: alleen voor uitwendig gebruik. Niet gebruiken indien u overgevoelig bent voor één van de bestanddelen.
- 3** **Direction:** if used externally, improves the skin condition and helps regenerating its structure.
Storage: store at 0-25 Celsius.
- 4** **Cautions:** for external use only. Do not use in case of idiosyncrasy for any component.

- 4** **Notice!!!** All warnings that are mandatory for application according to any of the annexes of Regulation (EC) No 1223/2009 are indicated. If one of the components has a link in the Regulations, for example: **For professional use only** – this should be indicated on the sticker.
- 5** Composition of the Cosmetic product!!! **Strictly according to INCI (composition must correspond to table data in MSDS and CPSR files)**. The ingredients that are indicated in the composition of any cosmetic product are arranged in descending order of concentration: from greater to lesser. Components with a content of 1% or less can be listed in any order.

Threshold values of components to be indicated on the label:

- leave-on cosmetic products – specify all components up to a concentration of 0.001%;
 - rinse-off cosmetic products – all components are indicated up to a concentration of 0.01%;
 - for cosmetic products consisting of different components that are mixed immediately before use.
- Threshold values refer to the concentration of substances in the final mixture as for leave-on products;

The list of allergens that must be indicated on the packaging if their concentration in the composition exceeds:

- 0.001% in leave-on products (perfumes, etc.);
- 0.01% in rinse-off products (shampoos, soaps, etc.).

8 Batch number; European and American manufacturers are not legally required to indicate the expiration date of the product in closed form if it exceeds 30 months (2.5 years). For such cosmetic products, it is mandatory only to label the period of time after opening, and the shelf life of the product in closed form is into the batch code;

9 The icon of "Using the product after opening", the volume of the product; Other mandatory icons are applied depending on the Requirements of the Annexes of Regulation No. 1223/2009;

The language of information on the label must correspond to the language of the country of first entry of the cosmetic product or English

Labeling requirements

The European Cosmetic Regulation 1223/2009 requires you by law that the label of each product should contain the following data:

1. **Company name or registered name, city and country.**
Your company name and address (city, country) being the responsible person is required. Abbreviation/logo is allowed providing the name and address can be identified. Listing of phone number and website is optional. More addresses is allowed providing the name and address of the responsible person is highlighted.
2. **Country of Origin.**
USA.
3. **Contents in ml or grams.**
You have to list the contents except for the following cases:
 - a) when the packaging contains less than 5 milliliters or 5 grams
 - b) for free samples
 - c) single use products
4. **Batch number**
All products that you purchase from our company come standard with a batch number, with these numbers you can create your own.
5. **Period After Opening (PAO)**
All products that have a validation of more than 30 months, must be labeled with the PAO (Period After Opening) symbol  with or followed by the period in months and/or years. All products that have a validation of less than 30 months, should have an expiry date on them, preceded by the words 'best used before' or the applicable symbol . Symbols are listed in different formats for you to download. Dates to be expressed by month and year or day, month and year in that order.
6. **Warnings for use**
These can be read from the INCI listings. The sentences should be in your native language and/or language of country to which you export the product.
Special note: In case the packaging is too small, you may list the warnings on an enclosure sheet. When you refer to the enclosure sheet you should use the official hand-in-book symbol.




7. **Use of product unless this is clear from its presentation**
Description on what the use is of the product. The description should be in your native language and/or language of country to which you export the product.
8. **Statement: 'For Professional use only'** in case Hydroquinone and p-Hydroxyanisole or Benzoyl peroxide are listed ingredients. (see INCI listing)
9. **Statement: 'Read directions for use carefully'** in case Hydroquinone and p-Hydroxyanisole or Benzoyl peroxide are listed ingredients. (see INCI listing)
10. **List of ingredients (INCI)**
See INCI listings. Use a descending order weight of the ingredients. Ingredients in concentrations less than 1% may be listed in any order after those at concentrations of more than 1%. Colorants may be grouped at the end of the list

Fragrances have to be indicated by 'parfum' or 'aroma'. Fragrance allergens have to be listed too

For products marketed in several color shades, all colorants may be listed providing the words 'may contain' or the symbol '+/-' are added. The CI (Colour Index) shall be used.

In case the packaging is too small, you may list the ingredients on an enclosure sheet. When you refer to the enclosure you should use the official hand-in-book symbol.



- The flammable symbol  is not required, but can be added (if applicable, for large quantities only), other symbols are not required and should not be used.
